Applicant's age as of January 1st for the membership year determines the Initiation Fee bracket of the Junior Member.

ANNUAL DUES PAYMENT SCHEDULE

The annual dues plus applicable other fees are payable over an eight month period beginning January 1, 2010.

ELIGIBILITY

- Applicant must be between the ages of 30 and 35 years of age at the time of application.

FINANCIAL RESPONSIBILITIES

- All financial arrangements must be guaranteed with two active credit cards in good standing. In the event that the applicant cannot meet his/her obligations to the Club, the amount due will be automatically charged to their credit card account.
- Payments are due in a timely fashion as noted on invoices.
- Initiation Fee Payment Plan is available and can be found on the rate sheet.
- Annual Dues are paid in equal installments over the first eight (8) months of membership season.
- Failure to pay any amounts owed to the Club, as prescribed above, will result in suspension or termination of this membership. The decision to suspend/terminate is at the sole discretion of the owners of the Club.

MISCELLANEOUS RULES AND PRIVILEGES

- Cancellation of Membership: The cancellation of membership, by the applicant, is not possible once the Club has received the first payment (Initiation Fee).
- Leave of Absence: Each Junior Member is allowed the same one-year Leave of Absence that other members are entitled. However, this Leave of Absence does not relieve the Junior Member of financial responsibility for the Initiation Fee payment, which is due during this year. This amount is still due prior to January 1st of the “Leave” year. The year’s dues are waived as in any Leave of Absence case.

- Restaurant Minimums: The restaurant minimums required of the Junior Member until he/she reaches the age of 35 are a \$200.00 per quarter or a total of \$800.00 per year.
- Privileges: Junior Member(s) have the same Club privileges as their fellow Member(s) with regards to starting times and golf privileges.
- Lockers: Junior Member(s) may rent lockers only if they are available. All lockers are reserved first for full members.
- Junior Members, once they have reached the age of 35, become full members and make financial payments in the same manner as full members. At this age, the Junior Member also becomes responsible for the full restaurant minimum requirements.
- Junior Members have the privilege of adding spouse/children to membership. Corresponding dues, etc. are added in and payments remain broken down over eight (8) consecutive months.
- Bag Storage is a mandatory service.
- Handicapping is a mandatory service.
- The Tournament Fee is mandatory.
- Application may be made at any time during the course of the season. However, it is advised that said application be made prior to January 1st since Initiation Fee and Due will not be prorated for partial season/year.
