MEMBERSHIP

I WOULD LIKE TO WELCOME EVERYONE TO THIS YEAR'S 2010 SPRING MILL COUNTRY CLUB JUNIOR GOLF SEASON. WE HAVE EXPERIENCED A TREMENDOUS AMOUNT OF GROWTH OVER THE LAST 8 YEARS. WE BELIEVE WE NOW HAVE ONE OF THE TOP JUNIOR GOLF PROGRAMS IN THE EASTERN PENNSYLVANIA AREA. WE WOULD LIKE TO THANK ALL OF YOU FOR YOUR SUPPORT AND PARTICIPATION.

WITH THE GROWTH OF THE JUNIOR PROGRAM, AS WELL AS THE OVERALL MEMBERSHIP, WE ARE TRYING TO MAKE SURE ALL MEMBERS ARE ABLE TO MAXIMIZE THEIR USE OF THE SPRING MILL FACILITIES. I HAVE LISTED BELOW SOME OF THE GUIDELINES WE WILL BE UTILIZING THIS SEASON. WE LOOK FORWARD TO A GREAT 2010 SEASON.

1. JUNIOR MEMBERS MAY PLAY AT THE FOLLOWING TIMES:
APRIL 1st THRU OCTOBER 31st (IN SEASON)
WEEKDAYS: BEFORE 10:00AM AND AFTER 2:00PM WEEKENDS: AFTER 2:00PM
NOVEMBER 1st THRU MARCH 31st
WEEKDAYS: ANYTIME WEEKENDS: AFTER 1:00PM
2. THE DRIVING RANGE AND PRACTICE GREEN (WHICH IS LOCATED BY THE DRIVING RANGE) MAY BE USED ON WEEKDAYS FROM 1:00 PM 7:00 PM AND ON WEEKENDS FROM 12:00 - 6:00 PM. THESE TIMES ARE SUBJECT TO SLIGHT ALTERATIONS GIVEN WEATHER CONDITIONS, TOURNAMENT SCHEDULES AND ANY MAINTENANCE THAT NEEDS TO BE DONE. DUE TO THE SIZE OF OUR REGULAR PRACTICE GREEN AND THE AMOUNT OF USE IT RECEIVES FROM OUR REGULAR MEMBERSHIP, ALL NON-MEMBER JUNIORS ARE RESTRICTED TO USING ONLY THE DRIVING RANGE PRACTICE GREEN FOR ALL THEIR CHIPPING AND PUTTING.
3. EACH PLAYER REGISTERS IN THE GOLF SHOP BEFORE PLAYING. THIS IS DONE NOT ONLY TO TRACK ROUNDS THAT ARE PLAYED, BUT ALSO TO KNOW WHO IS ON THE GOLF COURSE IN THE EVENT WE NEED TO GET IN TOUCH WITH SOMEONE. THIS IS A NON-NEGOTIABLE CONDITION TO PLAYING THE GOLF COURSE. NON-COMPLIANCE WITH THIS RULE COULD RESULT IN THE SUSPENSION OF GOLF PRIVILEGES.
4. A JUNIOR MEMBER IS NOT PERMITTED TO USE A GOLF CART AT ANY TIME.
5. EACH JUNIOR MEMBER HAS A MEMBER NUMBER FOR IDENTIFICATION PURPOSES. HOWEVER, A JUNIOR MEMBERSHIP HAS NO CHARGING PRIVILEGES ATTACHED TO IT. ALL FOODS AND GOLF SHOP PURCHASES MUST BE PAID FOR WITH CASH, CREDIT CARD OR CHECK.
6. ALL FOOD AND BEVERAGE CONTAINERS MUST BE ACCOUNTED FOR AND DISPOSED OF PROPERLY.
7. JUNIOR MEMBERS ARE NOT ALLOWED TO BRING GUESTS TO PLAY GOLF. HOWEVER, WE DO HAVE A "JUNIOR MEMBER/GUEST" AND A JUNIOR PARENT/CHILD" EVENT. THESE DATES WILL BE PROVIDED AT THE BEGINNING OF THE GOLF SEASON.
8. THE JUNIOR MEMBERSHIP FEE INCLUDES A USAGE HANDICAP FEE. AS A MEMBER YOU ARE ALLOWED TO KEEP YOUR HANDICAP ON THE SPRING MILL HANDICAP COMPUTER IN THE GOLF SHOP.
9. THE FEE FOR THE NON-MEMBER JUNIOR GOLF MEMBERSHIP AT SPRING MILL IS \$1,000.00, PAYABLE IN FULL ON OR BEFORE MARCH 1, 2010. THE MEMBERSHIP IS AVAILABLE ON A FIRST COME FIRST SERVE BASIS.
10. TO BE ELIGIBLE FOR A NON-MEMBER JUNIOR MEMBERSHIP THE PLAYER MUST NOT HAVE REACHED THEIR 20th BIRTHDAY BY JANUARY 1, 2010.
11. HANDICAPPING IS A MANDATORY FEE OF \$50.00.
